



## Bonnie E. Raquet

### **Chair of the Board**

Bonnie Raquet has been a member of the Thrivent Board of Directors since 2010 and was elected to serve as chair of the board, effective February 2018. She also serves as chair of the Executive committee and as a member of the Governance committee.

In her leadership role, Raquet guides the board as it provides fiduciary and strategic oversight to Thrivent in its transformation to become a holistic financial services organization. Raquet was appointed by the U.S. Secretary of Agriculture and the U.S. Trade Representative to the Agricultural Policy Advisory Committee for Trade in 2008.

She is a member of the Global Advisory Council of TechnoServe Inc., a global economic development organization, and is vice-chair of the board of directors and chair of the Governance committee for The World Food Program USA. In addition, she served as vice-chair of the board of directors of Valparaiso University for ten years, where she chaired the Governance committee, and continues to serve as a board member. She also served as chair of the Luther Seminary Foundation board of trustees and as a member of the seminary's board of directors.

Raquet earned a bachelor's degree in history from Valparaiso University, a master's degree in history from Cleveland State University and her Juris Doctor cum laude from the University of Minnesota Law School. She is admitted to practice law in Minnesota and the District of Columbia.

Raquet and her husband, Peter, live in Williamsburg, Virginia. They have an adult daughter and are proud grandparents. Raquet is a member of St. Stephen Lutheran Church in Williamsburg.
