The 2024 America's Best Insurance Companies is an annual ranking presented by Forbes and Statista, a provider of market and consumer data. The 2024 list includes five insurance types: Auto, Homeowners, Renters, Term Life, and Permanent Life. The winners were determined based on an independent online survey conducted June 5-30, 2023 from a sample of over 15,000 U.S. citizens that were insurance company customers across the nation. For each insurance type, the insurance companies with the highest score have been awarded. To receive an award, insurance companies needed a minimum number of ratings and at least an overall score of 70 out of 100. Respondents rated the insurance companies on a variety of factors including general satisfaction, whether they would recommend, loyalty, and subdimensions such as advice, customer service, price-performance ratio, transparency, digital services and damage/benefit service.
