¹Plans F and G also have a high deductible option which require first paying a plan deductible of \$[2340] before the plan begins to pay. Once the plan deductible is met, the plan pays 100% of covered services for the rest of the calendar year. High deductible plan G does not cover the Medicare Part B deductible. However, high deductible plans F and G count your payment of the Medicare Part B deductible toward meeting the plan deductible. These expenses include the Medicare deductibles for Part A and Part B, but do not include the Plan's separate foreign travel emergency deductible.

²Plans K and L pay 100% of covered services for the rest of the calendar year once you meet the out-of-pocket yearly limit.

³Plan N pays 100% of the Part B coinsurance, except for a co-payment of up to \$20 for some office visits and up to a \$50 co-payment for emergency room visits that do not result in an inpatient admission.

Premiums

The following page(s) display the dollar amount of annual premiums. To determine the monthly or quarterly premium, complete the following calculations using the corresponding annual premium shown.

To calculate the monthly premium:

Multiply the annual premium amount shown on the chart by .0855.

Example:

$$\$1,500.00 \times .0855 = \$128.25$$

To calculate the quarterly premium:

Multiply the annual premium amount shown on the chart by .255, then add \$0.75.

Example:

$$(\$1,500.00 \times .255) + \$0.75 = \$383.25$$
