<sup>1</sup>Plans F and G also have a high deductible option which require first paying a plan deductible of \$2340 before the plan begins to pay. Once the plan deductible is met, the plan pays 100% of covered services for the rest of the calendar year. High deductible plan G does not cover the Medicare Part B deductible. However, high deductible plans F and G count your payment of the Medicare Part B deductible toward meeting the plan deductible.

<sup>2</sup>Plans K and L pay 100% of covered services for the rest of the calendar year once you meet the out-of-pocket yearly limit.

<sup>3</sup>Plan N pays 100% of the Part B coinsurance, except for a copayment of up to \$20 for some office visits and up to a \$50 copayment for emergency room visits that do not result in an inpatient admission.

## **PREMIUM INFORMATION**

We, Thrivent Financial for Lutherans, can only raise your premium if we raise the premium for all policies like yours in this state. Because your premium is based on attained age, your renewal premium will increase due to age; it will increase on or after the contract anniversary.

## **HOUSEHOLD PREMIUM DISCOUNT**

You will be eligible for a household premium discount if you have resided for the past year with at least one, but no more than three, other Medicare-eligible adult(s), at least one of whom owns or is issued a Medicare supplement contract from us. If the other individual is your legal spouse, including validly recognized civil union and domestic partners, you do not need to meet the one year requirement. The discounted premium will be priced 7% lower than the rates illustrated. Your contract's household premium discount will be removed if the last remaining individual upon whom your eligibility for the discount is based either (1) no longer has a Medicare supplement contract in force with us, or (2) no longer resides with you, other than in the case of his or her death.
